**Subj:** Glorious Harvest Farmers Market & Craft Show during the Autumn Glory Festival Sign Up

Commercial and Non profit vendor space is available during the Autumn Glory Festival at the Mountain Fresh Pavilion by the town parking lot in Oakland, Maryland October 10-12, 2013. Enclosed is the sign up sheet for vendor spaces, in case you are interested in participating. The schedule is:

Thursday October 10, 11 am to 5 pm  
Friday October 11, 9 am to 5 pm  
Saturday October 12, 9 am to 5 pm

Please note our fee schedule for non-profit groups. No free spaces will be distributed, as our cost for advertising Autumn Glory events has gone up. For non-profits not selling anything, that is, distributing information only, the cost is \$10 per day. For non-profits selling items for fundraising, the cost is \$20 per day. Commercial spaces are \$40 per day.

Wednesday is a regular farmers market day and we do not have room for non-members to set up. Friday we will try to have live music at the market. We are not having an official set up on Sunday, October 13, but you are welcome to set up that day if you wish. (This is not advertised).

Saturday the vendors usually have a potluck picnic in early afternoon (around 1:00 pm) when the parade starts (and the customer base disappears for a few hours during the parade). Feel free to bring a large dish or two to share (takeout is fine too!) & join us. Be sure to bring whatever plates, silverware and drinks you may need.

***The deadline for signing up for Autumn Glory is September 25.*** Please return your sign up sheet and payment to the address provided by that date.

Each space is at least 8' x 8'. Some 3' x 8' tables are available inside the pavilion, though you may have to provide your own table. You will know ahead of time if you need to bring a table. Space is also available outside the pavilion in the paved parking lot. Spaces will be allocated to Mountain Fresh Producers Association members first, and then other vendors will be given spaces at the discretion of the Mt. Fresh Autumn Glory Committee. We will try to accommodate each request.

The Mountain Fresh Producers Association reserves the right to deny access to the market pavilion during Autumn Glory by any business deemed inappropriate for the market. If it does so, all payments will be refunded to the business denied access.

**No refunds without prior approval of the Mt. Fresh Board of Directors; absolutely no refunds after October 1, 2013. We cannot accept credit cards. Pay with cash, check, or money orders only, please. Payments are due with your application.**
